## **Administrative Reports**:

**Mayor**: Mayor Foureman reported the following:

• Mayor Foureman reported that Dale Fisher did attend the Tuesday morning staff meeting, and she is 95% sure that Mr. Fisher understands what the problem is with his property and what he needs to do to fix it. Due to the cold weather making it hard to dig, Mayor Foureman told Mr. Fisher that when the weather warms up, she will reach out to him to set up a meeting between Mr. Fisher, Keir, Bill, and the Mayor to go through the situation again and give him a time frame to fix it. Mayor Foureman would like to pursue other options of attorneys to serve as the Village Solicitor now that the Village has been notified that Nicole Pohlman resigned from Goubeaux & Brand. She would then make a recommendation to Council concerning a new Solicitor. The Mayor asked if there were any objections to her doing that. Boolman asked if the Village is under a contract with the current Solicitor. Mayor Foureman explained that the Village is in the second year of the current contract. However because Ms. Pohlman resigned and was the Solicitor named in the current contract, the contract is now open. There were no other objections.

**Solicitor:** Nothing at this time.

<u>Village Administrator</u>: Sinnes reported on the following:

- Three fencing companies were contacted for an estimate to fix the damage to the fence by the Utility Department. One company, Hess, came back with an estimate of \$1326.
- As stated before, the Village deductible for that type of damage is \$2500, so the Village will likely move forward with having Hess complete the repair.
- The new Water Department employee, Ryan Berning, who started on December 21, 2015 decided that the position was not going to work out and resigned on December 29, 2015.

Mayor Foureman stated as soon as the Utility Committee is determined, there are three items that the committee will need to meet about and address immediately.

(S. Main St. Reconstruction & Sewer Funds) A motion was made by Van Hoose to waive the three reading rule on Ordinance No. 2015-66. Clark seconded. All present voted yea. A motion was made by Boolman to waive the three reading rule on Resolution No. 2015-41. Clark seconded. All present voted yea. Boolman made a motion to adopt Resolution No. 2015-41. Clark seconded. **Expenditures:** Mayor Foureman asked for a motion to approve the expenditures. Boolman inquired about a "Restock" fee of \$828 on the voucher list. Woodall clarified that the \$828 was not a restocking fee but was actually for restocking inventory commonly used in the Utility Department. Willis asked if any late fees had been incurred as a result of the vouchers not being able to be approved at the December 29, 2015 Council meeting due to a lack of a quorum. Woodall explained that she has not encountered any instances of late fees to this point. If she does find that any late fees were incurred, she will report it to Council. A motion was made by Boolman to pay the properly appropriated and funded expenditures. Van Hoose seconded. All present voted yea. Motion passed.

Willis asked if any more information was received from Clemans and Nelson about how many other entities would be part of the "group" employee manual or cost. Delk and Mayor Foureman stated they have not heard anything.
