Village of Arcanum Council Meeting August 30, 2022 7:00 p.m. Regular Session Public Hearing

(Proposed Zoning Map & Text Revisions and Amendment to the Codified Ordinances of the Planning And Zoning Code)

<u>Call to Order</u> – Mayor Bonnie Millard opened the meeting with the Pledge of Allegiance along with all present members of Council.

Roll Call – The following council members were present: Ryan Burns, David Hartley, Jerry Boolman, Eric VanHoose, Rick Genovesi and Jacob Banks. Also in attendance were VA Bill Kessler, Fiscal Officer Toni Stanley, Solicitor Nicole Pohlman, Police Chief Marcus Ballinger, Missie Shilt and Kris Kollmeyer.

<u>Public Hearing</u> – Proposed Zoning Map & Text Revisions and Amendments to the Codified Ordinances of the Village of Arcanum's Planning and Zoning Code. Mayor Bonnie Millard opened the public hearing for discussion. There were no questions or concerns were raised; therefore, Mayor Bonnie Millard closed the public hearing.

<u>Meeting Minutes – Corrections and Approvals</u> – <u>Council Member Boolman moved to approve the regular meeting minutes dated 8/9/2022. Council Member Hartley seconded. All present council members voted yea. <u>Motion passed.</u></u>

Amendments to Agenda - None at this time.

<u>Comments from the Public</u> – Kris Kollmeyer discussed the repairs the Village was making to his property as he is wanting to replace several boards on the barn before the barn is painted. The Village stated a local company would be there on 9/9/22 to begin painting. Mr. Kollmeyer agreed that if he replaced any boards after the painting was finished, he would be responsible and required to have them repainted.

Administrative Reports -

Mayor:

- Purple Heart Ceremony planning has been underway for some time; everything is coming together for the September 17th ceremony.
- A closing date for the Orme Hardware building is planned.

Solicitor: Nothing at this time.

Village Administrator:

- EPA Discharge License has been renewed; no response yet on the water tower violations.
- District 11 VA has been provided last year's score sheet and will be forwarding to Ronnie at Access.
- PCA Revenue is currently down due to the summer temperatures; hoping that once things increase at Family Dollar and the new grocery store is running, revenue will increase. The PCA will be increasing a half a cent. Arcanum's electric with a PCA increase is still cheaper than AES.

Fiscal Officer:

- Acceptance of Properly Appropriated and Funded Expenditures.
- Financial reports were included in Council Packets.
- Covid Utility Forgiveness Resident is requesting forgiveness on their last utility bill in the amount of \$572.94. Resident has provided the required documentation for the Covid utility forgiveness and funds are available. Council Member Banks moved to approve the covid utility forgiveness in the amount of \$572.94. Council Member Hartley seconded. All present council members voted yea. Motion passed.
- Tax Department Department receives constant requests to take credit card payments. Extensive research has been done and the Tax Administrator has found a suitable company to offer this service. Bridge Payment provides all the equipment and software at no charge to the Village.

Discussion was held on the possibilities of whether in the future this system could also be used for utility payments. VA stated that it may be a service that could be utilized by the pool down the road, but probably not for utilities. It was explained to Council that the system does not interface, but is a mere credit card transaction. There will be a service fee of \$0.50 (minimum) or 3.5% of the transaction amount charged to the customer by the credit card service provider. Service will require a contract; solicitor will have legislation for Council for next meeting.

Darke County Budget Commission has sent out apportionments for local government funds which is 4.5% for 2023. <u>Council Member Banks moved approve the 4.5% apportionment accessed by the Darke County Budget Commission for Local Government Funds in 2023. Council Member Genovesi seconded. All present council members voted yea. Motion passed.

Police Chief:

- Department assisted the Darke Co. Sheriff's Office with active shooter training in the school. Superintendent is currently working on a grant to update the door system within the school.
- Arcanum PD has been providing mutual aid to the DCSO due to them being short staffed.
- School Chief sent out a one call at the beginning of the school year reminding everyone of safe practices. Radar signs have been moved to the school zones. Meeting with the Kindergarten Club on October 5th to explain lock downs and the role of the SRO.
- New radios have been ordered and should be installed sometime in October.

- September 24th Chief will be holding "Coffee with a Cop", in the Council Chambers from 10-12pm. This will give the department an opportunity to have conversations with the residents on topics of concern.
- Staffing Officer Daughtery has accepted a position with the City of Greenville Police Department and will be leaving sometime in September. Chief Ballinger recommends immediately hiring Officer C. Trembley to a full-time position. <u>Council Member Genovesi moved to hire Officer Christine Trembley to the position of full-time officer once Officer Daughtery resigns. Council Member Hartley seconded. All present council members voted yea. Motion passed.</u>
- Department has been awarded a grant from CJS in the amount of \$20,000.00 to be used for the retention of employees to be used over the next 2 years.

Committee Reports

Safety: Report given by Rick Genovesi. Next meeting is scheduled for 9/14/2022 at 5:00pm.

- Traffic Light Project Committee reviewed the received quote of approximately \$118,000. Village will get
 estimates for the remaining materials/labor needed. VA informed Council that ODOT would like additional
 equipment added bringing the total project cost to an estimated \$140,000.00. Superintendent Stephens
 will be speaking with the School Board on contributing funds to the project.
- Fire Department It was discussed that obstacles on the railroad is preventing the fire department from quickly reaching certain locations. A resolution is being discussed by the Mayor, VA and School Superintendent. The new fire truck is being built and a new firefighter has been added.
- Police Department Speeding is still a problem in some residential areas of the Village. To aide in the
 issue, new 25 MPH speed limit sign will be ordered and posted around the Village with the main focus on
 the side street/ residential areas. Signs are approximately \$80 a piece with 15 signs being currently
 needed. Council Member Hartley moved allow the expenditure of \$1,500.00 for new speed limit signs.
 Council Member Genovesi seconded. All present council members voted yea. Motion passed.

General discuss was had between Council Members, Police Chief and Missie Shilt.

- Violations Kollmeyer barn will be painted on the 9th by a local company as a community project. Additionally, the roof vent is being fixed.
- Pool Baby pool is still having problems and committee is looking for different options.
- Park Someone had an issue with a shelter house being rented; problem was resolved. Several trees need cut down at a cost of \$14K and is currently not a budgeted item. Park & Rec Committee is applying for an Urban Canopy grant to purchase new trees and is also looking for donations from residents within the Village.
- Discussion was held on making the old city building part of the Park District.
- Mommy & Me swing has been ordered and should be installed by October.
- Dug out repair is moving along with the block work in progress already.
- Streets Committee agreed to recommend to Council to allow the VA to begin the bidding process for the resurfacing of West South Street.
- Parks & Rec Committee VA recently met with the Cross County Coach about laying out a preliminary
 course for next year; Committee is applying for a tree grant and has a goal of placing 10 new trees in the
 park; converting a basketball court to a pickleball court.
