<u>Call to Order</u> – Mayor Bonnie Millard opened the meeting with the Pledge of Allegiance along with all present members of Council.

Council Member VanHoose seconded. All present council members voted yea. Motion passed.

Administrative Reports -

Mayor:

• Clemens & Nelson has reviewed the Personnel & Procedure's Manual and will have recommended changes to the Personnel Committee by September.

Solicitor: Nothing at this time.

Village Administrator:

Hometown Cable – VA recommends and request that the Village terminate the Exchange of Service
Contract with Hometown Cable due to their lack of performance and reliability. VA would also like
Solicitor to prepare a letter to Hometown Cable requesting the removal of their equipment from Village
property.

Discussion was held on how this would effect residents; effects to the Village as a whole; other service providers; legal process to terminate contract; potential revenue for the Village; future changes needed for this type of contract. Council Member Boolman moved to terminate the Villages contract with Hometown Cable. Council Member Hartley seconded. All present council members voted yea. Motion passed. Solicitor will prepare a 90-day notice of termination letter to Hometown Cable.

T-N-R Program — 16 cats have been through the program at this time. Mayor stated that residents interested in donating funds to the program may drop off a check made out to the Darke Co. Humane Society to the Village Offices for convenience. VA stated that the majority of residents who had been feeding the stray cats have discontinued the practice.

Fiscal Officer:

- Acceptance of Properly Appropriated and Funded Expenditures.
- Financial reports were included in Council Packets.
- Tax receipts are 3% higher at this time last year. Delinquent Accounts 86 total; 2 for 3 years; 6 for 2 years. Total funds delinquent is \$27,000.00.
- Liquor Permit Family Dollar has submitted to the State for a new liquor permit.

Council Member Hartley asked the question on what type of liquor the permit would allow to be sold. Discussion followed on the type of alcohol allowed by the type of permit applied for and whether the Village should request a hearing to the State. Council Member Boolman moved to allow the Fiscal Officer to deny the request for a public hearing to the State Liquor Board in regards to a liquor permit request from Family Dollar. Council Member Hartley seconded. All present council members voted yea. Motion passed.

Police Chief:

- Midyear report was provided in Council Packets.
- Personnel 2 officers are beginning the hiring process with the City of Greenville; this will potentially cause gaps in providing 24/7 coverage to the Village. 1 officer is almost complete with FTO.
- Officer Tina Silvers has submitted her resignation as of 8/1/22. <u>Council Member Hartley moved to accept the resignation of Officer Tina Silvers effective 8/1/22. Council Member Burns seconded. All present council members voted yea. Motion passed.</u>
- Radars Community has provided great feedback on the new radar signs. The collected data from the radar signs assist the police department in how the Village is patrolled. Chief will be meeting with the Safety Committee to discuss speed limits within the Village.
