Village of Arcanum Council Meeting August 29, 2023

6:00 - Tour of the Old Town Hall - Preservation Society 7:00 p.m. Regular Session - Preservation Society Building

<u>Call to Order</u> – Mayor Bonnie Millard opened the meeting with the Pledge of Allegiance along with all present members of Council.

Swearing In - Appointed Council Member Calli Means was sworn in by Mayor Millard.

Roll Call – The following council members were present: Eric VanHoose, David Hartley, Calli Means, Rick Genovesi, Jerry Boolman and Ryan Burns. Also in attendance were Solicitor Nicole Pohlman, VA/Police Chief Marcus Ballinger, Admin. Specialist Julie Miller, Nicholas Jackson, Amra Jackson, Beth Cox, Gordon Cox, Bev Rench, Chris Kessler, Chloe Price, Bruce Shack, Brad Proctor, Missie Shilt, Angela Herron, Jim Peele and Jarod Fox.

<u>Swearing In – Police Chief Ballinger presented a candidate for hire to the Police Department and asked that Council approve the hiring of the candidate. Council Member Genovesi moved to hire Nicholas Jackson as an officer to the Arcanum Police Department at Step A of the wage scale effective 9/4/2023. Council Member Hartley seconded. All other present council members voted yea. Motion passed.</u> Mayor Millard proceeded with swearing in Nicholas Jackson to the Arcanum Police Department.

<u>Meeting Minutes – Corrections and Approvals</u> – <u>Council Member Hartley moved to approve the regular meeting minutes dated 8/8/2023. Council Member VanHoose seconded. Council Member Boolman and Council Member Means abstained. All other present council members voted yea. Motion passed.</u>

<u>Amendments to Agenda</u> – Addition of Ord.#2023-33.

Comments from the Public - None.

Administrative Reports -

Mayor:

- Vicki Rhodehamel has suggested having a live nativity scene in the park during Christmas in the Park. She
 is reaching out to the other churches in the community to see if there would be enough participation to
 do such an event.
- Old Town Hall Mayor thanked the Preservation Society (PS) for providing a tour before the council meeting of the renovations made thus far to the building. PS expressed their concern in doing a whole bunch of work to the building, and then a few years down the road another council decides to take the building from under them. PS expressed their interest in being able to apply for grants for the remaining repairs. Mayor asked the question on whether the PS would have any interest in buying the building from the Village and Township. The PS is not opposed to the idea, but needs to do more research on the idea. Council Member Hartley stated that he would have no problem passing a resolution offering support to the Preservation Society, but the resolution would not mean much if another council wanted to do something with the building. The PS mentioned maybe a contract would be more feasible. Council, Mayor, Solicitor, and PS members spoke in general on different options available and what is most feasible for all the parties involved. Council Member Burns asked whether the PS would have investors in purchasing the building. It was mentioned that any type of sale or lease agreement would have to be advertised. The PS liked the idea of owning the building, but would need to do some number crunching with their Treasurer on what they could afford to pay for the building. They will reach out to the VA after their next meeting.

Solicitor: Nothing currently.

Village Administrator/ Police Chief: Reports were provided in Council Packets. VA Report-

- When making the budget last year, it was not budgeted to have money in the park fund for the upfront
 cost of the walking path at the gazebo if the reimbursement grant was awarded. In the north section of
 the Preserve a culvert needs to be placed, to make the trail passable for \$1,500.00. Council Member
 Hartley moved to spend up to \$7.5K out of the ¼% Fund with \$6K to be reimbursed for the walking path
 at the gazebo and \$1,500.00 for the culvert. Council Member VanHoose seconded. All present council
 members voted yea. Motion passed.
- Council Member Boolman moved to approve a sewer forgiveness for 502 W. George Street in the amount of \$162.00. Council Member Hartley seconded. All present council members voted yea. Motion passed.
- Updates and additional information on the Police Department have been added to the Villages website.
- New janitorial services for the Village Office have begun and is going well.
- Consolidated Tank began painting the outside of the water tank. The bottom of the tank looks good and should not need any extensive repairs for another 5-6 years.

Council Member Hartley brought up that there is a trampoline under the tank presently. VA Ballinger stated that he frequently has to have the resident remove items from under the water tank. Council Member Boolman questioned whether the water tank should be fenced in.

• Land Survey – The Darke Co. Commissioners have put out a land survey for residents of Darke County to participate in to determine what the county residents would like to see in their communities. The survey is being put on free of charge by OSU for a class project.

- Sewer plant paddle gears have arrived; brine tank and one of the wells have been cleaned.
- Solar policy Sawvell is working on drafting this policy and will be ready by next year.
- Electric Charge Sawvell is recommending that we drop our PCA charge for the consumption months of August to January to zero dollars due to collecting too much.
- AMP During the process of building a new substation, AMP will be the Villages "Agent" in negotiations with AES.

Finance & Audit: Nothing to report.

Service and Leisure: Report given by Calli Means. Next meeting scheduled for 9/7/23 @ 5pm is cancelled.

- Walking path at the gazebo.
- Pickleball Tournament was good, and many more residents than expected have been using the court. Will start on turning the basketball court in Ivester Park to a multipurpose court in early fall.
- Ball Diamonds Painting of the shed will occur. Discussed a rubber coating for the tennis court.
- Pool Discussed the overall condition of the pool and different issues that are present.
- Nature Preserve Welcome sign has been erected; planning to add a few additional directional/trail name signs. Utility Department has been working on making the trails wider. Plans on adding a culvert to one part of the trail. Park & Rec Committee Council Member Hartley moved to approve the expenditure of \$500 for the Arcanum Nature Preserve welcome sign. Council Member VanHoose seconded. All council members voted yea. Motion passed. Park & Rec Committee would like to hold a scavenger hunt on some of the trees that they have given unique names to.
- Grants- Should find out in October if the Trails Grant was awarded.
- Violations- Going very well. Mayor discussed with Council a group sidewalk shaving project that involves
 various residents on 4 different streets in town. Mayor advised that on these four streets there are a lot of
 sidewalks that have small trip hazards, and a local contractor will be preforming a group shaving or lifting
 project. Mayor handed out a letter for council to review that would be sent out to residents.

Council Member Hartley moved to amend the previous motion of approving the expenditure of \$500 for the Arcanum Nature Preserve welcome signs to \$564.00. Council Member VanHoose seconded. All council members voted yea. Motion passed.
