Service will be constructed from the Village water main to curb shut-off valve by the Village if not already in place to the connecting property. The property owner/customer is responsible for expenses to install the sanitary sewer lateral from the right-of way or easement line to the structure. A sanitary sewer lateral clean-out is required outside of the foundation wall of the structure and a clean-out is required at the right-of-way or easement line. The property owner/customer is responsible for expenses to plumb the meter inside the structure and install the service line from the curb valve meter to the meter. Meter pits are prohibited for new construction unless otherwise approved by the Village. The owner must install a quarter-turn shut off valve on both sides of the meter for draining.  4. A backflow prevention device is required for all industrial, commercial, and institutional customers. Any residential customers with any other pressurized water source entering the building or any potential for hazardous cross-connections, as determined by the Village, must install an approved backflow prevention device. Backflow devices shall be tested annually by a certified technician who is licensed in the State of Ohio and must provide a report to the Village.  5. Rules and Regulations related to sanitary sewer service are outlined in Ordinance No. 2024-42. Tap Fees per Current Fee Schedule.  6. Rules and Regulations related to water service are outlined in Ordinance No. 2024-42. Tap Fees per Current Fee Schedule.  7.
